Bid due date and time	Thursday, March 27, 2025 by 11:30 AM
Questions	In writing up to seven days prior to bid opening. All responses will be in the form of an addendum.

Bidder Qualifications	<b>Qualifications include three years in business registered as a contractor <u>under the same name in Washington State, completed the L&amp;I public works training, and have a Workers Comp Experience Factor of 1.0 or better (the experience factor requirement may be waived after review of written explanations).</u></b>
Bid Guarantee	NOT Applicable to this project.
Performance and Payment Bond	100% Performance and Payment Bonds required upon Contract Award.
Tax (included in bid price)	Retail Sales Tax does not apply to labor costs. Tax does apply to Materials as stated in WAC 458-20-17001.
Prevailing Wages	Washington State Prevailing Wages do apply to this project; residential rates may be used when available.
Permits	Contractor is responsible for all permits and costs associated.
Payment Terms	30 days from date of invoice approval.
Retainage	5% or 10% held until 45 days after final completion and release from L&I, DoR, Employment Security (above \$35K) and Affidavit of Wages Paid filed.
Occupied Buildings	Fully occupied and access must be coordinated with the Owner.
Contract Duration	30 calendar days.
Work Hours	Between 8:00 a.m.-6:00 p.m. Monday-Friday (excluding holidays).
Time Extension	Time extensions will be considered for outside delays such as review and inspections and weather days. Additional funds will not be paid for extensions.
Material Storage	Four parking spaces will be available for storage. Vehicles should be parked off site.
Scope	Work includes but is not limited to: Good faith asbestos inspection(s) testing to comply with RCW 49.26.013 as required to achieve scope of work. Removal and replacement of all existing roofing materials and 50% of plywood deck sheathing as well as 100LF of fascia board. Inspect all exposed roof framing for any rot or damaged materials and repair as needed.
Substitutions	Substitution requests will be reviewed after bid opening.
